## RETURNS AND REPAIRS

Under EXTREME circumstances a Return Merchandise Authorization (RMA) number may be granted on a case by case basis. **RMA # MUST obtain prior to sending back products.** Packages received by our shipping department that do not have a valid RMA# clearly visible on the shipping label/box will be refused and Returned to Sender (RTS) at the shippers expense. Defective merchandise is subject to inspection, repair or replacement at JAG Precision's sole discretion. All returns must have appropriate documentation included (i.e. Note explaining defect or problem, copy of sales receipt/invoice and RMA#). ## JAG Precision Definition of MAP

1. An advertisement that includes a price lower than the set MAP for an advertised product, or has the effect of advertising a price below the MAP for that product (i.e. "price-off coupon", "rebate", "tokens", "any kind of gift option", "too low to show", "rewards points", "storewide sale" or any MAP manipulation) does not comply with the MAP policy.

2.) For purposes of the MAP Policy, the term "advertising". Includes advertisements placed with television, radio, newspapers, magazines, catalogs, email mailers/blast or any kind flyers (including direct-mail flyers, coupons, or catalogs sent by dealers to their customers), web pages and sites and other methods of advertising on the internet.

3.) JAG Precision MAP policy does not include walk in store (brick n mortar) advertising or promotions.

4.) Customers/Dealers not adhering to these guidelines will have any orders suspended (temporarily or permanently) until prices are modified/adjusted to comply with JAG Precision Map Policy.

5.) All changes will be effective immediately and compliance required by October 31st, 2013. Thank you for understanding the importance of regulating the price and promotions to ensure the future value of our products, which will benefit everyone. Jag Precision will not require any agreement with any dealers. It will be entirely up to the dealer whether to comply or not.

Jag Precision will allow Dealers to participate in online/walk-in sales with USA major holidays, Store Grand Openings and Store Yearly Anniversaries. Only during this time that JAG Precision will allow the Dealers to have **up to Fifteen Percent (15%) off** discount store wide (online and walk-in).

Here's a complete list of the Major Holidays that JAG Precision Will Allow Up to 15% off MAP Products and the Maximum Duration of the Sale/Promo, NO set date as long as it's within the set time duration.

- New Year's Day: 4 days Sale Max
- President's Day: 3 days Sale Max
- Memorial Day: 4 days Sale Max
- Independence Day: 3 days Sale Max
- Labor Day: 4 days Sale Max
- Columbus Day: 3 days Sale Max
- Veterans Day: 3 days Sale Max
